Reception Locations

The Thousand Islands Winery has 2 separate locations available for your special day. A rental fee of \$500.00 allows you to have four hours of time in both facilities.

Additional time may be added.



When you walk up the stairs you will be taken back by the beauty of this area. This historic 1920's Sears Catalog Kit Barn has been refinished to keep the rustic feel intact. The high ceilings, chandelier lights, and large side doors that can be opened for a beautiful view set the stage for a very intimate affair. This space can comfortably accommodate up to 100 guests. This area also includes a bar available if you choose to have a private bartender for your guests. We can serve our wines as well as water and soft drinks in this area.



The courtyard adjacent to the Tasting Room is the perfect location for your outdoor events. In addition to the grassy courtyard, there is also a pavilion in case of inclement weather. The bar in this space has beer, wine, & soft drinks available for your guests. Enjoy the view of the vineyards and the timeless Thousand Islands Bridge from this location.

Ceremony Locations

The Thousand Islands Winery proudly offers wedding ceremonies on site.

Ceremony Courtyard:

This is the most popular location for ceremonies at the Thousand Islands Winery. Located adjacent to Frontenac Hall, this courtyard boasts all the privacy and beauty one could desire for their wedding ceremony. The lush green grass leads up to the wedding arbor centered in front of our vineyard. Your guests will enjoy the quiet view of the vineyards, the winery, and perhaps one of the ships on the nearby river.

You may opt to have your guests standing for your ceremony with only a few chairs for those unable to stand for the duration or rent them from an independent rental company.

Bar Options

All alcohol for your event must be purchased through The Thousand Islands Winery. You may choose from any of the wines made by the Thousand Islands Winery or a wide variety of beer. Hard spirits are not permitted on the property. You have the option of choosing whether you would prefer to have an open or cash bar for your event.

Open Bar: An open bar can be set at any limit you desire for your event. A deposit is required for the limit set prior to the start of your event. A Thousand Islands Winery bartender is required for this option at a rate of \$15.00 per hour. The bartender will keep a tally of all wine, beer, and soda served during your event. When the amount consumed is approaching the predetermined limit, the bartender will notify the person in charge of the bar costs. You have the option of adding additional money to the limit or changing over to a cash bar.

Cash Bar: A cash bar gives your guests the option to purchase alcohol if they choose to do so during your event. A Thousand Islands Winery bartender is required for this option at a rate of \$15.00 per hour.

Bottle Purchases: Bottles of wine may be purchased at a discounted rate of 15% off to be consumed during your event. Consumption must be by only adults 21 & older.

Beer: Beer is only permitted in the outside courtyard / pavilion and requires a special permit. The beer permit requires 4-6 weeks for approval and is \$36.00 to file. Feel free to request that your favorite beer be available for your guests.

Entertainment

Music System: The use of the Thousand Islands Winery music system is free of charge for your event. You may bring mixed CD's or an IPOD to play music throughout your event.

*A Thousand Islands Winery staff member can be booked to change CD's and run the sound system at a rate of \$15.00 per hour.

DJ: Many guests opt to book a professional DJ during their event. Feel free to choose any DJ that you feel most comfortable with.

Band: Bands may also be booked to play during your special day. At your request, The Thousand Islands Winery can provide you with contact information for several bands that may be available for your event.



Decorating & Clean Up

The Thousand Islands Winery staff will provide the set up and tear down of our tables and chairs for your event free of charge. Our tables are 8' banquet tables and the chairs have a blue seat. They are shown in the earlier pictures of the banquet facility decorated for a wedding. You may opt to rent round tables and folding chairs. An additional charge will apply for setting up rented tables and chairs.

Self Decorating: You may arrange a time during our business hours to come in and decorate the day of or the day prior to your event.

-Recommendations: White Christmas Lights, flowers, table centerpieces, battery operated candles, etc.

-Restrictions: Glitter, confetti, or candles are not permitted as decorations. (Battery operated Candles are suggested as an alternative)

Other Vendors: Arrangements for vendor drop off and set up should be made prior to your event. For example: Florists, Wedding Cake, Equipment Rental (Tents, chairs, linens, etc.)


Linens & Silverware: Linens and silverware are not provided by the Thousand Islands Winery. You may opt to rent these through your caterer or party rentals.


Clean Up: Thousand Islands Winery staff will clean up following your event. This is included in your rental fee.
